


# Child-Rearing Support Allowance to Address Rising Prices

Receive a one-time payment of **20,000 yen** per eligible child!

## ■ Q. Do I need to apply?

A. In principle, no application is required.

Note: If you are required to apply, please refer to “3” below.



## 1. Who is eligible? (Eligible Children)

The following children are eligible.

- (1) Children eligible to receive the Child Allowance for September 2025\*  
(\*October 2025 for children born in September 2025)
- (2) Children born between October 1, 2025 and March 31, 2026

## 2. How much is the allowance? (Payment Amount)

20,000 yen per eligible child (one-time payment).

## 3. Who needs to apply?

In principle, the following individuals are required to apply.

Please apply using one of the methods described in this notice.

- Guardians of children born between October 1, 2025 and March 31, 2026
- Public servants receiving the Child Allowances from their government office (Please refer to “6” on the back)
- Guardians who had to apply for the Child Allowances on or after October 1 due to a divorce (including divorce mediation in progress and the like)

## **4. How can it be received? (Payment Method)**

### **(1) The Child Allowance recipients**

In principle, the allowance will be paid into **the bank account currently used to receive the Child Allowance.**

Note: If the transfer cannot be processed due to bank account closure, changes, or similar reasons, the allowance will not be paid. Please be sure to contact the help desk below by **February 6,2026.**

### **(2) Guardians who applied ( Those who fall under “ 3 ”) .**

The allowance will be paid into **the designated bank account specified in your application.**

## **5. What if...**

### **■ What if I moved?**

The allowance will be **paid by the municipality (including designated area) where the Child Allowance was paid for September (October for children born in September 2025)** and transferred to the bank account used to receive the Child Allowances or the account specified in the notification form. For inquiries, please contact the municipality where you previously resided.

### **■ What if my child/children and I have fled our home due to domestic violence?**

If you have already completed the procedures to change the recipient of the Child Allowance in the municipality to which you have fled, you are eligible to receive this allowance. Please contact the municipality as soon as possible. You do not need to update your certificate of residence or contact your spouse's municipality.

## **6. For public servants**

Public servants should first confirm the procedural details with their government office.

To ensure smooth payment of the allowance, we recommend registering a Public Money Receiving Account. (Please note that registering a Public Money Receiving Account alone does not complete the application process for this allowance.)
